

EAnnual Grants are awarded for projects that make positive impact on student learning and support the NEF Mission. Applications open in November and close in late January/early February. Awarded grants will be funded on July 1 for implementation the following school year. To ensure that your innovative idea has the best possible opportunity for approval, please review the Annual Grants guidelines before starting an application.

# **Grant Procedures and Guidelines**

### ALL GRANTS MUST BE:

- Initiated by a District 203 staff member or student and support at least one D203 school
- Approved by the Principal
- Aligned to your school's Improvement Plan and/or to a curricular area or standard or the school's high value need

#### GUIDELINES

- Grants are awarded in the following categories:
  - Diversity and Inclusion
  - Fine Arts and Physical Education
  - Social Emotional Learning (SEL)
  - Science, Technology, Engineering and Math (STEM)
  - Literacy grants are funded through the Jeanine Nicarico Memorial Literacy Fund
- Preference will be given to original, innovative proposals or proposals that are of the highest value to the school.
- High value parent engagement programs will be considered if the Principal or designated staff member is the author and supervises/oversees implementation.
- Student submissions must be approved and supervised by a teacher and/or administrator who must also be the Grant Lead.
- Materials provided by the grant become the property of the school where the grant originated and not the property of any individual or group. Unused project funds will be returned to NEF.

#### **IMPORTANT TO NOTE**

- NEF will not consider funding other nonprofit organizations.
- Grants are not awarded for salaries, furniture, fundraising efforts or storage materials.

#### PROCESS AND TIMELINE

- Awarded Grants will be funded after July 1 for implementation in the next school year.
- Grant applications will be reviewed by current and former NEF Trustees, District 203 faculty, staff and administration, community members and District 203 retirees.
- Responses must be clear and specific and describe what the requested funds will purchase and what implementation will look like. Acronyms should be avoided or defined.
- A completed evaluation report including a financial recap will be required for all funded grants
- At the conclusion of your project, you will be required to submit a report consisting of an evaluation form and financial recap. Please remember to keep any documentation (invoices, receipts, surveys, videos, photographs, etc.) that may be needed to complete this report. Any unused project funds will be returned to NEF.
